Bill, "AN ACT to Require Principles of Reimbursement
for Intermediate Care Facilities for the Mentally
Retarded to Include Provisions for Covering Increases
in Insurance Premiums."

Amend the Bill by striking out everything after
the title and inserting in its place the following:

'Be it enacted by the People of the State of Maine as
follows:

Sec. 1. .22 MRSA §3189 is enacted to read:

§3189. Principles of reimbursement for insurance
premium

Principles of reimbursement established for
intermediate care and boarding care facilities for the
mentally retarded shall provide the necessary and
sufficient reimbursement as fixed expenses for all
insurance coverages required of licensed facilities
and shall include a process for adjustment of facility
rates when premium increases are beyond control of the
facility. Directors' and officers' liability coverage
shall be included in the principles.
