17 §3189. Principles of reimbursement for insurance 18 premium

19 Principles of reimbursement established for 20 intermediate care and boarding care facilities for the 21 mentally retarded shall provide the necessary and sufficient reimbursement as fixed expenses for 22 a11 23 insurance coverages required of licensed facilities and shall include a process for adjustment of facility 24 rates when premium increases are beyond control of the 25 26 facility. Directors' and officers' liability coverage 27 shall be included in the principles.
