Resolve, for Laying of the County Taxes and Authorizing Expenditures of Oxford County for the year 1987.

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

9 Whereas, Oxford County has certain expenses and 10 liabilities which must be met as they become due; and

11 Whereas, it is necessary that the taxes for the 12 year 1987 hereinafter mentioned be immediately as-13 sessed in order to provide the required revenue for 14 the county; and

1 Whereas, in the judgment of the Legislature, 2 these facts create an emergency within the meaning of 3 the Constitution of Maine and require the following 4 legislation as immediately necessary for the preser-5 vation of the public peace, health and safety; now, 6 therefore, be it

Re-8 That the following sum is hereby granted as solved: 9 a tax on Oxford County to be apportioned, assessed, collected and applied to the purposes of paying debts 10 and necessary expenses of the county as authorized 11 herein, and for other purposes of law, for the calen-12 13 dar year 1987:
