STATEMENT OF FACT

Section 1 of the bill allows for buying, selling
or trading whole bears if they are marked with a bear
tag provided by the commissioner. Section 2 makes it
illegal to buy, sell or barter bear parts. Section 3
makes it illegal to possess bear parts other than the
teeth, head, gall bladder, claws or hide except bear
parts that have been given as gifts. Section 4 ex-
empts certain parts from the prohibition on selling
hear narts
