7 COMMITTEE AMENDMENT " \mathcal{H} " to H.P. 511, L.D. 684, 8 Bill, "AN ACT to Enhance the Activities of the Maine 9 Highway Safety Committee."

10 Amend the bill in section 3 by striking out all 11 of subsection 4 and inserting in its place the fol-12 lowing:

13 Maine Highway Safety Commission. The Maine '4. 14 Highway Safety Committee Commission, as authorized by 15 Title 5, section 12004, subsection 10, which shall be 16 under the direction of the Commissioner of Public Safety and advisory to the Governor. The committee 17 commission shall consist of not more than 25 members selected by the Governor from state, civic and indus-18 19 20 trial organizations and individuals with interests relating to highway safety. The Commissioner of Pub-lic Safety, the Commissioner of Transportation, the 21 22 23 Commissioner of Human Services and the Commissioner 24 of Educational and Cultural Services, the Secretary 25 of State and the Attorney General shall serve as ex officio members. The ex officio members shall ap-26 27 point persons in major policy-influencing positions as their designees to represent them at meetings of 28 29 the commission with voting privileges. The committee 30 commission members shall serve at the pleasure of the Governor and shall be compensated in accordance with Title 5, chapter 379. The committee commission shall stimulate active support for highway safety measures 31 32 33 34 and programs and shall advise the Department of Pub-35 Safety regarding these issues;-and. The commislic 36 sion shall annually report its findings and recommendations, including any necessary implementing legis-37 38 lation, to the Governor and to the joint standing committee of the Legislature having jurisdiction over state and local government; and 39 40

COMMITTEE AMENDMENT "H" to H.P. 511, L.D. 684

Further amend the bill in section 4, 2nd paragraph 1 (page 3, line 5 in L.D.) by striking out "State" and 2 3 inserting in its place the following: 'State' 4 STATEMENT OF FACT This amendment provides that the constitutional officers and the commissioners who are ex officio 5 6 members of the Maine Highway Safety Commission will 7 appoint persons in major policy-influencing positions 8 9 to represent them with voting authority at commission 10 meetings. The commissioners and constitutional offi-11 cers are extremely busy people and may not be able to attend some of the commission meetings. 12 13 This amendment also provides that the commission will report findings and recommendations along with 14 15 any necessary implementing legislation to the Gover-16 nor and the Legislature. 17 The amendment also corrects the title of the 18 Maine State Bar Association. 19 2571042787
