STATEMENT OF FACT

The purpose of this bill is to require consumers selling cars to a used car dealer to sign a written disclosure statement detailing all known damage and mechanical defects. By signing this document, consumers will be confirming that they have fully disclosed the condition of the car to the used car dealer. This information is later disclosed by the dealer to prospective buyers.
