5 Be it enacted by the People of the State of Maine as
6 follows:

7 **Sec. 1.** 36 MRSA §191, sub-§2, ¶J, as amended by
8 PL 1985, c. 764, §4, is further amended to read:

9 J. The disclosure to a state agency seeking set-
10 off of a liquidated debt against a tax refund
11 pursuant to section 5276-A of information neces-
12 sary to effectuate the intent of that section;
13 and

14 **Sec. 2.** 36 MRSA §191, sub-§2, ¶K, as enacted by
15 PL 1985, c. 764, §5, is amended to read:

1 K. The disclosure by a municipal assessor, or by
2 the State Tax Assessor with regard to the unorga-
3 nized territory, of information contained on the
4 declaration of value form required by section
5 4641-B, to a person who has filed an application
6 for abatement pursuant to section 841. Informa-
7 tion which may be disclosed is limited to infor-
8 mation which is relevant to the determination of
9 just value of the property for which the form was
10 filed; and

11 Sec. 3. 36 MRSa §191, sub-§2, ¶L is enacted to
12 read:

13 L. The disclosure to any authorized representa-
14 tive of the Department of Human Services when the
15 representative seeks access to tax records of a
16 delinquent payee of child support, in order to
17 ascertain the whereabouts of the payee.

18 STATEMENT OF FACT

19 This bill will allow the Department of Human Ser-
20 vices access to tax records in cases where the where-
21 abouts of a delinquent payee of child support is un-
22 known.
