COMMITTEE AMENDMENT "A " to S.P. 324, L.D. 952,
"Resolve, Creating the Commission to Study the Use of
Involuntary Services for Substance Abusers."

Amend the resolve by striking out all of the 3rd
paragraph before the emergency clause (page 3, lines
8 to 12 in L.D.) and inserting in its place the fol-
lowing:

'Assistance. Resolved: That if staff assistance
is desired, assistance shall be requested from the
Legislative Council. The Department of Human Ser-
vices shall provide the commission with staff assist-
ance and pertinent existing information to carry out
these duties; and be it further'

Further amend the resolve in the last paragraph
before the emergency clause, in the 3rd line (page 3,
line 27 in L.D.) by striking out the following: "Ex-
ecutive Director" and inserting in its place the fol-
lowing: 'Chairman'

Further amend the resolve by inserting before the
emergency clause the following:

'Appropriation. The following funds are appro-
priation from the General Fund to carry out the pur-
poses of this resolve.
