IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-SEVEN

Resolve, to Provide a One-year Moratorium on School-based Health Clinics and Establish the Commission to Study Clinics in Public Schools which provide Counseling and Services Relating to Pregnancy.

One-year moratorium on school-based health clinics. Resolved: That there shall be a moratorium from the effective date of this resolve to April 1, 1988, on the establishment of any new health clinics in public schools which provide counseling and services relating to pregnancy. The purpose of the moratorium is to permit a study and make a report to the Legislature; and be it further

15 Funding. Resolved: That there is appropriated 16 from the General Fund to the commission the sum of 17 \$12,000 to carry out the purpose of the study; and be it further 18

19 Compensation. Resolved: That legislative members shall receive per diem compensation and all oth-er members shall be reimbursed for travel and other 20 21 22 necessary expenses; and be it further
