1 **Resolve, Creating the Portsmouth Naval**
2 **Shipyards Economic Policy Commission.**
3

4 **Commission established. Resolved:** That the
5 Portsmouth Naval Shipyards Economic Policy Commission
6 shall be comprised of the following members: Two
7 Senators to be appointed by President of the Senate;
8 2 Representatives to be appointed by the Speaker of
9 the House; and one member representing management of
10 the shipyard and one member representing the workers
11 of the shipyard to be appointed by the Governor. The
12 commission shall select a chairman from among its
13 members; and be it further

14 **Study. Resolved:** That the commission shall
15 study the following issues in an effort to assist the
16 Portsmouth Naval Shipyards to accomplish its goals and
17 advance into the 21st Century:

1 1. Labor-related issues;

2 2. The feasibility of providing state economic
3 assistance to the shipyard;

4 3. Guidelines for a more successful acquisition
5 of contracts; and

6 4. Identification and formulation of sound eco-
7 nomic policy for the shipyard; and be it further

8 **Compensation. Resolved:** That legislative mem-
9 bers shall receive the legislative per diem and other
10 commission members shall be compensated for their ac-
11 tual expenses; and be it further

12 **Appropriation. Resolved:** That the sum of \$5,000
13 be appropriated from the General Fund to carry out
14 the purposes of this resolve; and be it further

15 **Report. Resolved:** That the commission shall
16 submit its report, together with any necessary imple-
17 menting legislation to the Second Regular Session of
18 the 113th Legislature.

19 **STATEMENT OF FACT**

20 This resolve establishes the Portsmouth Naval
21 Shipyard Economic Policy Commission. The commission
22 shall consist of Legislators and members representing
23 the management and workers of the shipyard. The com-
24 mission will report to the Second Regular Session of
25 the 113th Legislature.
