10 11	Amend the bill by inserting after the title and before the enacting clause the following:
12	'Emergency preamble. Whereas, Acts of the Legis-
13	lature do not become effective until 90 days after
14	adjournment unless enacted as emergencies; and
15	Whereas, legislation was passed in 1985 which
16	provided for a budget committee of municipal offi-
17	cials to approve the Waldo county budget; and
18	Whereas, this legislation provided for all mem-
19	bers to be elected in 1985 and every 2 years thereaf-
20	ter; and
21 22 23	Whereas, it is desired to increase the length of the terms to 3 years and to stagger the times when the terms shall end; and
24	Whereas, the budget committee is to be elected at
25	least 90 days prior to the end of the county's fiscal
26	year which is at the end of the calendar year; and
27	Whereas, in the judgment of the Legislature,
28	these facts create an emergency within the meaning of
29	the Constitution of Maine and require the following
30	legislation as immediately necessary for the preser-
31	vation of the public peace, health and safety; now,

In view of the emergency cited 17 the preamble, this Act shall take effect when apin proved.' 18 19 STATEMENT OF FACT The original bill had assumed that the county fiscal year ends on June 30th, whereas it, in fact, 20 21 ends December 31st. This amendment revises the dates 22 in the bill so that the changes in member terms can 23 24 be in effect for the next biannual election which is 25 in the fall of 1987 and places the bill on an emer-26 gency basis so that it will be in effect at the time 27 of this year's election.
