Amend the Bill in section 1, in that part design-
ated "§702." by striking out all of the last sen-
tence (page 2, lines 7 to 11 in L.D.).

Further amend the Bill by striking out all of
section 2 and inserting in its place the following:

'Sec. 2. 30 MRSA §1051, as amended by PL 1983,
c. 74, §§1 to 3, is further amended by adding at the
end a new paragraph to read:

The county commissioners of each county may re-
quire that the fees collected under subsections 1, 2,
3, 5, 7, 10, 19 and 20 be increased by \$1. The sher-
iff or deputy shall collect this additional dollar
and pay it to the county treasurer for the use and
benefit of the county.'

This amendment leaves the decision to the county
commissioners of each county whether the fees for
service of certain process should be increased by \$1.
If the county commissioners approve the increase, the
\$1 will be collected and paid to the county.
