12 STATEMENT OF FACT

13 Numerous drivers have been observed turning right 14 on a red light even though a posted sign indicated "NO RIGHT TURN ON RED." This creates a serious 15 health and safety condition for other drivers, pas-16 sengers and pedestrians. It appears most illegal turns are not done because drivers flaunt the law, 17 18 19 but because while observing the traffic light, they 20 do not see the no-turn posted sign. Attachment of 21 the necessary sign would focus ones attention on the 22 traffic light and the no-turn sign simultaneously to 23 increase the protection of the public.
