7 HOUSE AMENDMENT "^A" to COMMITTEE AMENDMENT "B"
8 to H.P. 962, L.D. 1291, Bill, "AN ACT to Implement
9 the Recommendations of the Driver Education Evaluation
10 Program Study."

11 Amend the amendment in section 2, in that part
12 designated "§7203." in subsection 3, by inserting at
13 the end the following:

14 'The division may require completion of the first of-
15 fender program to satisfy the requirements of the
16 multiple offender program if an approved multiple of-
17 fender program is unavailable for the client. In
18 such cases, the fee schedule for the first offender
19 program applies.'

20 Further amend the amendment in section 2, in that
21 part designated "§7206." in subsection 2, paragraph
22 A, in the 3rd line (page 6, line 23 in amendment) by
23 inserting after the underlined word "program" the
24 following: ', including the initial evaluation' and
25 in paragraph B, in the 2nd line (page 6, line 26 in
26 amendment) by striking out the underlined word
27 "evaluation" and inserting in its place the follow-
28 ing: '2nd and subsequent evaluations'

29 Further amend the amendment in section 2, in that
30 part designated "§7207." in subsection 2, by striking
31 out all of the 5th line (page 7, line 5 in amendment)
32 and inserting in its place the following: 'a current
33 certificate to provide driver education evaluation
34 and treatment services during'

35 Further amend the amendment in the emergency
36 clause, in the 4th line (page 14, line 26 in amend-
37 ment) by inserting after the following: "section
38 7207," the following: 'and Title 29, section 1312-B,

3 This amendment:

4 1. Corrects the reference to certificates issued
5 by the Division of Driver Education Evaluation Pro-
6 gram;

7 2. Delays implementation of the multiple offend-
8 er program and provides a nonavailability waiver to
9 allow the department flexibility in implementing this
10 program; and

11 3. Clarifies the multiple offender program fee
12 schedule to ensure that it includes the initial eval-
13 uation.
