Bill, "AN ACT to Provide Special License Plates and
Decals for People with Hearing Impairments."

10 Amend the Bill in the title, in the 3rd line by 11 inserting after the following "Impairments" the fol-12 lowing: 'and to Amend the Law Concerning Handicapped 13 Plates and Placards'

14 Further amend the Bill by inserting after the en-15 acting clause the following:

16 'Sec. 1. 29 MRSA §252, first ¶, as repealed and 17 replaced by PL 1987, c. 56, §1, is repealed and the 18 following enacted in its place:

19 On annual application to the Secretary of State, 20 any handicapped person or the spouse, parents or legal guardian of a handicapped person who has regis-tered a motor vehicle as the motor vehicle of princi-pal use by the handicapped person shall be issued a set of special designating plates to be used in place 21 22 23 24 25 of the regular registration plates or placard to be 26 fixed to the sun visor of a motor vehicle registered by such a person. The placard shall be so affixed 27 that the information thereon shall be clearly legible 28 29 from outside the motor vehicle. The placard issued 30 under this section shall include the motor vehicle registration plate number of the vehicle registered 31 in the name of the handicapped person or the spouse, parents or legal guardian of the handicapped person, the name of the handicapped person and the date of expiration of the placard. The Secretary of State shall establish by regulation a system of color cod-32 33 34 35 36 37 ing for placards issued pursuant to this section for 38 the purpose of facilitating the determination of va-39 lidity of placards. 1 deems it appropriate, a placard may be issued to any handicapped person who does not have a duly regis-tered motor vehicle. In such cases, the placard may 2 3 be displayed on any motor vehicle properly registered in this State, but it may only be so displayed during the time when the handicapped person is a passenger 4 5 6 vehicle, when the driver of the vehicle is 7 the in 8 transporting the handicapped person or when the driv-9 er is waiting for a service to be rendered to the 10 handicapped person. The annual registration fee is 11 as set forth in this subchapter for the type of vehicle assigned the special designating plates 12 or placard. A \$1 fee shall be charged in those cases where a placard is issued to a handicapped person who 13 14 does not have a duly registered motor vehicle. 15

16 Sec. 2. 29 MRSA §252, next to the last ¶, as 17 amended by PL 1987, c. 56, §2, is further amended to 18 read:

Any person other than a handicapped person or the spouse of a handicapped person issued a set of special designating plates or placard under this section shall be subject to a \$100 fine for use of the special designating plates or placard. The special designating plates or placard shall be suspended if improper use is permitted.

26 Sec. 3. 29 MRSA §252, last ¶, as amended by PL 27 1987, c. 56, §3, is repealed and the following en-28 acted in its place:

29 <u>These special designating plates shall bear the</u> 30 International Handicap Symbol.

31 Sec. 4. 29 MRSA §252-C, last ¶, as amended by 32 PL 1987, c. 56, §6, is further amended to read:
