COMMITTEE AMENDMENT "H" to H.P. 1185, L.D. 1615, Bill, "AN ACT to Amend the Maine Vocational-Technical Institute System Laws."

Amend the bill in section 2 in subsection 1 in paragraph B in the 2nd line (page 2, line 23 in L.D.)
by inserting after the word "Maine" the underlined word 'System'

Further amend the bill in section 2 in subsection 7 in the 3rd line (page 2, line 34 in L.D.) by striking out the figure "5" and inserting in its place the following: '6'

Further amend the bill by striking out all of section 6.

Further amend the bill in section 9 in the 2nd and 3rd lines from the end (page 5, lines 11 and 12 in L.D.) by striking out the following: "State and Local Government" and inserting in its place the following: 'Appropriations and Financial Affairs

Sec. 11. Study. The joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs shall conduct a study to evaluate the cost of, and alternatives to, creating a separate administrative structure for the Maine Vocational-Technical Institute System.

The committee shall organize a subcommittee to investigate these issues.
