1 AN ACT to Correct an Incorrect Personnel
2 Description in the Law Relating to the
3 Board of Pesticides Control.

5 Emergency preamble. Whereas, Acts of the Legis-
6 lature do not become effective until 90 days after
7 adjournment unless enacted as emergencies; and

8 Whereas, Public Law 1985, chapter 627, incorrect-
9 ly describes the personnel intended to be funded by
10 that chapter; and

11 Whereas, this incorrect description defeats the
12 purpose of the chapter, which was to enable the Board
13 of Pesticides Control to hire a seasonal inspector to
14 provide additional inspection capability during the
15 May to October spray season; and

1 Whereas, the correction of the description as
2 provided herein will enable the board to fulfill the
3 purpose originally intended by the chapter; and

4 Whereas, in the judgment of the Legislature,
5 these facts create an emergency within the meaning of
6 the Constitution of Maine and require the following
7 legislation as immediately necessary for the preser-
8 vation of the public peace, health and safety; now,
9 therefore,

10 Be it enacted by the People of the State of Maine as
11 follows:

12 Public Law 1985, c. 627, §2 is repealed and the
13 following enacted in its place:

14 Sec. 2. Allocation. The following funds are al-
15 located from other special revenue to carry out the
16 purposes of this Act.
