12 Amend the amendment by inserting after the first  
13 paragraph after the title the following:

14 'Further amend the bill in section 5 in the 4th  
15 line (page 4, line 9 in L.D.) by inserting after the  
16 following: "subcommittee" the following: 'of the  
17 Joint Standing Committee on Legal Affairs'

18 Further amend the amendment in section 6 in the  
19 3rd line (page 1, line 21 in amendment) by striking  
20 out the following: "the current allocation" and in-  
21 sserting in its place the following: 'current re-  
22 sources'

23 Further amend the amendment by striking out all  
24 of section 7 and inserting in its place the follow-  
25 ing:

26 'Sec. 7. Appropriation. The following funds are  
27 appropriated from the General Fund to carry out the  
28 purposes of this Act.
