STATEMENT OF FACT

2           This amendment amends the committee amendment to  
3 clarify that the money raised by issuance of bonds  
4 under the bill may be used for improvement of exist-  
5 ing and construction of new jail facilities for  
6 Androscoggin County. The amendment also requires  
7 that the county commissioners hold a meeting with the  
8 legislative delegation and the County Jail Planning  
9 Committee within 30 days after adjournment of the  
10 Legislature to finalize details of the bond issue be-  
11 fore its submission to the voters.
