to H.P. 1424, L.D. 1935, Bill, "AN ACT to Strengthen
Penalties for Persons Piloting Boats Under the
Influence of Alcohol."

Amend the amendment in section 4 in subsection 13
in paragraph A in the 7th to 9th lines (page 3, lines
13 to 15 in amendment) by striking out the following:
"and the court shall suspend the defendant's right to
operate a motorized watercraft for a period of 90
days" and in the next to the last line (page 3, line
16 in amendment) by striking out the following:
"penalties" and inserting in its place the following:
'penalty'

Further amend the amendment in section 4 in
subsection 13 in paragraph B in the 6th line (page 3,
line 23 in amendment) by inserting after the
following: "\$300," the following: 'and' and in the
8th to 10th lines (page 3, lines 25 to 27 in
amendment) by striking out the following: "and the
court shall suspend the defendant's right to operate a
motorized watercraft for a period of 90 days"

Further amend the amendment in section 4 in
subsection 13 in paragraph C in the 6th line (page 3,
line 42 in amendment) by inserting after the
following: "\$500," the following: 'and' and in the
7th to 10th lines (page 4, lines 1 to 4 in amendment)

15 following: ", including a suspension,"

16 Further amend the amendment in section 5 by
17 striking out all that part designated "\$7913."

18 Further amend the amendment in section 5 by
19 renumbering that part designated "\$7914." to be
20 '\$7913.'

21 Further amend the amendment in section 8 in
22 subsection 3 by striking out all of paragraph A.

23 Further amend the amendment in section 8 in
24 subsection 3 by relettering paragraph B to be
25 paragraph A.
