1           **RESOLVE, to Extend the Deadline for the Study of**  
2           **the Relationship between Nonprofit Service**  
3           **Agencies and Professional Liability and Other**  
4           **Hard-to-Obtain Lines of Liability**  
5           **Insurance.**

7           **Emergency preamble.** Whereas, Acts and resolves  
8 of the Legislature do not become effective until 90  
9 days after adjournment unless enacted as emergencies;  
10 and

1         Whereas, the committee established pursuant to  
2         Resolve 1987, chapter 65, requires additional time to  
3         complete its study; and

4         Whereas, the completion deadline has already  
5         passed; and

6         Whereas, in the judgment of the Legislature, these  
7         facts create an emergency within the meaning of the  
8         Constitution of Maine and require the following  
9         legislation as immediately necessary for the  
10         preservation of the public peace, health and safety;  
11         now, therefore, be it

12         **Resolve 1987, chapter 65.     Resolved:**     That  
13         Resolve 1987, c. 65, 5th ¶ from the end before the  
14         emergency clause, is amended to read:

15         **Findings.     Resolved:**     That the committee shall  
16         report its findings and any recommended legislation to  
17         the Legislature by ~~November 15, 1987~~ February 15,  
18         1988; and be it further

19         **Emergency clause.**     In view of the emergency  
20         cited in the preamble, this resolve shall take effect  
21         when approved.

22                                     STATEMENT OF FACT

23         This resolve extends the reporting deadline for  
24         the Joint Standing Committee on Banking and Insurance.
