Amend the bill in section 1, in paragraph B, in the 11th and 12th lines (page 2, lines 9 and 10 in L.D.) by striking out the following: "he thereafter actively attends and makes satisfactory progress in" and inserting in its place the following: 'that person is in'

16 Further amend the bill in section 2, in paragraph 17 A, by striking out all of the first paragraph (page 3, 18 lines 10 to 27 in L.D.) and inserting in its place the 19 following:

'A. If a dislocated worker, as defined in section 1196, subsection 1, who is in training approved under section 1192, subsection 6, 6-A or 6-B, constitution for a sector defined therefore were the sector of the sector base of the sector of 20 21 22 qualifies 23 for an extended benefit year additional benefits under section 1043, subsection 24 5, paragraph B, or exhausts the maximum amount of his entitlement to benefits available to him 25 26 27 under this subsection, the maximum amount under 28 this subsection shall be increased by the 29 product of his most recent weekly benefit amount 30 multiplied by the number of weeks in which he 31 thereafter attends an approved training program.
