## STATE OF MAINE SENATE 113TH LEGISLATURE SECOND REGULAR SESSION

7 COMMITTEE AMENDMENT " A " to S.P. 885, L.D. 2297, 8 Bill, "AN ACT to Enhance the Effectiveness of the 9 Operating-Under-the-Influence Laws."

10 Amend the bill by striking out everything after 11 the enacting clause and inserting in its place the 12 following:

13 'Sec. 1. 28-A MRSA §2518, as enacted by PL 14 1987, c. 45, Pt. A, §4, is amended to read:

### 15 §2518. Informal evaluation

16 The joint standing committee of the Legislature 17 having jurisdiction over legal affairs shall conduct 18 an informal evaluation evaluations of this Act, to 19 be completed within 2 years and 4 years of its 20 effective date. The evaluation evaluations shall 21 address the effectiveness of the Act in achieving its 22 stated purposes.

23 Advisory Commission on the Effectiveness Sec. 2. 24 of the Operating-Under-the-Influence Laws. There is 25 established the Advisory Commission on the Effectiveness of 26 the Operating-Under-the-Influence Laws consisting of 14 members. The membership shall 27 be as follows. 28

Standing Committee on Legal Affairs, one to be appointed by the Speaker of the House and one to be appointed by the President of the Senate.

4 2. One member shall represent the Department of 5 the Attorney General and shall be appointed by the 6 Attorney General.

7 3. One member shall represent the district 8 attorneys of the State and shall be appointed by a 9 statewide association of district attorneys.

10 4. One member shall represent alcohol and drug 11 abuse treatment providers and shall be appointed by 12 the Maine Association of Substance Abuse Providers.

13 5. One member shall represent the Department of 14 Human Services and shall be appointed by the 15 Commissioner of Human Services.

6. One member shall represent the Department of
 Corrections and shall be appointed by the Commissioner
 of Corrections.

19 7. One member shall represent the Department of 20 Public Safety and shall be appointed by the 21 Commissioner of Public Safety.

8. One member shall represent the Department of
the Secretary of State and shall be appointed by the
Secretary of State.

9. One member shall represent the county sheriffs
and shall be appointed by a statewide association of
sheriffs.

28 10. One member shall represent the police chiefs 29 and shall be appointed by a statewide association of 30 police chiefs.

31 11. One member shall represent the Maine chapter 32 of the National Council on Alcoholism.

33 12. One member shall represent the Maine chapter 34 of the Mothers Against Drunk Driving.

1 13. One member shall represent alcohol servers 2 and shall be appointed by the Maine Restaurant 3 Association.

Sec. 3. Appointment schedule; notification; chairman; meetings. The appointing authority for 4 5 each member shall make the required appointment within 30 days of the effective date of this section and 6 7 8 shall notify the Executive Director of the Legislative 9 Council as soon as the appointment is made. The 10 Executive Director shall convene the first meeting within 45 days of the effective date of this section. 11 12 The membership of the commission shall elect а chairman from its membership. The commission 13 is authorized to meet 10 times. Support staff shall be 14 15 provided by the Legislative Council and the 16 departments represented.

The commission shall examine 17 Sec. 4. Duties. the current operating-under-the-influence laws and 18 their effectiveness in deterring, sanctioning and rehabilitating or treating drunk and drugged driving offenders, and ways to improve current laws. The commission shall examine current information reporting 19 20 21 22 procedures concerning drunk and drugged driving 23 statistics, and ways to improve the current system. 24 25 · In considering improvements to the existing laws, the commission shall examine the use of immediate license suspension for those arrested for operating under the 26 27 28 influence and the use of ignition interlock devices, 29 including a review of the use of the devices in other 30 The commission shall report its findings and states. 31 recommendations, together with any suggested 32 legislation, to the Joint Standing Committee on Legal 33 Affairs by January 15, 1990.

34 Sec. 5. Compensation. All members of the 35 commission not employed by the Executive Department of 36 State Government shall receive expenses and 37 legislative members shall receive legislative per diem.

38 Sec. 6. Appropriation. The following funds are 39 appropriated from the General Fund to carry out the 6.

These costs will result from the Joint 23 24 25 26 27 Standing Committee on Legal Affairs evaluating the 28 Maine Liquor Liability Act 4 years after its effective 29 date.' 30 STATEMENT OF FACT The purpose of the original bill and this amendment is to create a commission to study the 31 32 effectiveness of the current operating-under-the-influence laws. The commission will report to the 33 34 35 114th Legislature in 1990.

The commission will be made up of 14 members ٦ 2 representing the Joint Standing Committee on Legal Affairs, the Department of Human Services, the Department of Corrections, the Department of Public Safety, the Department of the Secretary of State, and 3 4 5 6 district attorneys, sheriffs, chiefs of police, 7 substance abuse treatment providers, alcohol servers, 8 the National Council on Alcoholism and Mothers Against 9 Drunk Driving. The commission shall examine the laws 10 and the extent to which operating-under-the-influence 11 offenders are deterred, punished, rehabilitated or 12 treated. The commission shall also look at the information reporting system and the use 13 of the 14 immediate suspension of drivers' licenses of persons 15 arrested for operating under the influence. The 16 commission will also examine the use of ignition 17 interlock devices.

In addition, this bill, as amended, requires the Joint Standing Committee on Legal Affairs to reexamine the liquor liability laws in another 2 years. Although the review completed this year was helpful, not enough time has passed for reliable statistics to be generated. Another review in 2 years will give the Legislature an opportunity to see if the changes made in 1986 have been effective.
