7 Personal health management Α. to maximize 8 personal well-being in relation to the adult's 9 disability, provided by a registered nurse or other qualified person experienced rehabilitation of the severely 10 in the 11 severely physically 12 disabled, including all aspects of prevention, 13 maintenance and treatment techniques;

14 B. Personal care assistant management, provided a registered nurse experienced 15 by in the rehabilitation of the 16 severely physically 17 disabled, including training in recruiting, hiring 18 and managing a personal care assistant; 19 scheduling; potential problems; and

C. Functional skills required to maximize the
adult's abilities in activities of daily living,
provided by a registered occupational therapist
experienced in the rehabilitation of the
severely physically disabled.

25 Sec. 4. Personal care assistants; wages, 26 benefits and overnight pay. The Bureau of Rehabilitation, in establishing and administering a 27 28 program of personal care assistance services for 29 severely disabled adults, shall expand its present program to serve an additional 20 new consumers and 30 shall provide through contract with providers of in-home personal care assistance for an average 31 32 compensation rate of \$7 an hour for personal care assistants, payment of \$12 each night for each client to overnight attendants and the establishment of a pro 33 34 35 36 rata group benefits package, not to exceed \$1,000 for each personal care attendant, including health insurance, vacation and sick leave for personal care 37 38 39 assistants. In overseeing the use of funds for increased wages of personal care assistance workers, 40 41 the Bureau of Rehabilitation shall take into account 42 regional variations in the cost of living and

1 competitive wage rates across the State.

2 Sec. 5. State Medicaid plan. The Bureau of Medical Services shall adopt personal care assistance 3 services as part of the state Medicaid plan. 4 These 5 regulations shall be designed to allow for personal assistance services to be provided in a manner that allows the consumer to achieve maximum control over that consumer's life while minimizing the orientation to a medical model whenever possible, which will 6 7 8 9 10 result in reducing the overall costs.'

12 This amendment deletes references to the Citizen's 13 Commission on Independent Living and the Home-Based 14 Advisory Committee and retains language concerning 15 personal care assistance. Funding for personal care 16 assistance and a Medicaid buy-in program is provided 17 in the Supplemental Budget.
