AN ACT Concerning the Display of Dealer Markup Stickers by New Car Dealers.

4 Be it enacted by the People of the State of Maine as 5 follows:

6 Sec. 1. 10 MRSA §1174, sub-§4, ¶A, as enacted 7 by PL 1975, c. 573, is amended to read:

A. To require a purchaser of a new motor vehicle,

as a condition of sale and delivery thereof, 1 to 2 also purchase special features, appliances, equipment, parts or accessories not desired 3 or 4 requested by the purchaser; provided, however, 5 this prohibition shall not that apply as to 6 special features, appliances, equipment, parts or accessories which are already installed on the car 7 8 when received by the dealer; provided further, 9 prior that the motor vehicle dealer to the the 10 consummation of the purchase reveals to 11 purchaser the substance of this paragraph;

STATEMENT OF FACT

This bill provides that, whenever a dealer attaches a dealer markup sticker to a new car, and that markup does not represent any additional features, appliances, equipment, parts or accessories installed or services performed by the dealer, the words "additional dealer markup" must appear on that sticker.
