20 January 15, 1989, and
21 January 15, 1990.
22 This pilot project
23 shall terminate on
24 June 30, 1990, unless
25 specifically extended
26 by the Second Regular
27 Session of the 114th

19 STATEMENT OF FACT

20 This amendment allocates additional alcohol
21 premium funds to create a 2-year pilot project to
22 implement a data collection and evaluation system for
23 substance abuse treatment clients. The pilot project
24 would terminate on June 30, 1990, unless specifically
25 extended by the 114th Legislature.

26 This amendment also deallocates alcohol premium
27 funds in fiscal year 1987-88 to fund a program in
28 fiscal year 1988-89.
