1 STATEMENT OF FACT

This amendment changes the Aroostook County and, subsequently, the total municipal cost components at the request of the Aroostook County delegation to fund ambulance service amounting to \$3,875 for several unorganized territories surrounding Ashland. It also adds an appropriation to begin work on a new school in Rockwood Strip. This amount will be reimbursed through an existing surplus in the Unorganized Territory Education and Services Fund.
