1 Sec. 17. 20-A MRSA \$\$13019-D and 13019-E, as 2 enacted by PL 1985, c. 287, \$5, are amended to read:

3 §13019-D. Recertification of administrators

Administrators who hold certificates issued in accordance with chapter 501 shall continue to hold 4 5 those certificates until their termination dates. Renewal of administrator certificates issued in accordance with chapter 501 which are granted after the effective date of this Act September 19, 1985, and before July 1, 1988, shall be valid for 5 years. All certificates issued after June 30, 1986, 6 7 8 9 10 11 shall be issued in accordance with this chapter. Administrators who hold certificates issued in accordance with chapter 501 shall have those 12 13 14 15 certificates renewed at each future termination date 16 in accordance with chapter 501.

17 §13019-E. Recertification of other professional 18 personnel

Professional personnel other than teachers and 19 administrators who hold certificates issued pursuant to chapter 501 of this Title shall continue to hold those certificates until their termination dates and 20 21 22 shall have those certificates renewed at each future 23 termination date in accordance with chapter 501. 24 All certificates issued after June 307 19887 shall be 25 26 issued and renewed in accordance with rules of the state-board-adopted-pursuant-to-this-chapter-' 27

STATEMENT OF FACT

2 The purpose of this amendment is to clarify the status of current teachers, administrators and other 3 4 professional educational personnel with respect to recertification. This amendment clarifies existing law to provide that educational personnel who hold 5 6 valid certificates shall renew those certificates at each subsequent expiration date according to the renewal requirements of the Maine Revised Statutes, Title 20-A, chapter 501, in effect at the time the 7 8 9 10 11 certificate was issued.
