12 Amend the amendment by striking out everything
13 after the title and inserting in its place the
14 following:

15 'Amend the bill in the title in the 2nd line (page
16 1, line 2 in L.D.) by striking out the figure
17 "\$31,800,000" and inserting in its place the figure
18 '\$36,800,000'

19 Further amend the bill in section 1 in the 6th
20 line (page 2, line 11 in L.D.) by striking out the
21 figure "\$31,800,000" and inserting in its place the
22 figure '\$36,800,000'

23 Further amend the bill in section 6 in the 5th
24 line (page 3, line 14 in L.D.) by striking out the
25 figure "\$31,800,000" and inserting in its place the
26 figure '\$36,800,000'

27 Further amend the bill in section 10 in the
28 question in the first line (page 4, line 13 in L.D.)
29 by striking out the figure "\$31,800,000" and inserting
30 in its place the figure '\$36,800,000'
