Further amend the bill in that part designated <u>\$13075.</u>" in subsection 3 in paragraph B in the first line (page 3, line 22 in L.D.) by striking out the following: "<u>A 10-year</u>" and inserting in its place the following: '<u>A capital investment</u>'

18 Further amend the bill in that part designated 19 "<u>\$13075.</u>" in subsection 4 by striking out all of 20 paragraph A and inserting in its place the following:

7 The \$1,000,000 appropriation included in this bill 8 has also been included in the Governor's supplemental 9 budget request. If this request is included in the 10 final enacted version of the supplemental budget, then 11 the appropriation section on the bill should be 12 deleted.'

STATEMENT OF FACT

14 This amendment clarifies 2 provisions concerning eligibility for economic growth corridor grants. 15 The provision concerning a 10-year capital investment has 16 been replaced with a requirement that a municipality 17 a capital investment plan included in its 18 have 19 comprehensive plan. Municipalities which have demonstrated a commitment and effort to the development and improvement of infrastructure will be one of the categories for which priorities for grants 20 21 22 due are to be considered. 23
