COMMITTEE AMENDMENT "A" to H.P. 1933, L.D. 2634

- Further amend the bill in section 1, in that part designated "§7101." by adding at the end the following:
- '4. Failure to notify. Any entity which fails to file notice with the department required by this section, shall not be approved to receive financial assistance from the State, as defined in section 4211-A, subsection 1, for one year next following the date the notice is required to be filed.'
- 9 Further amend the bill by renumbering the sections to read consecutively.

11 STATEMENT OF FACT

12 This amendment deletes certain items from criteria to be considered in review by the Department 13 of Transportation of an application for financial 14 assistance. It requires that those items be addressed in the notice given to the department by an entity which proposes to acquire or construct an additional railroad line, or to provide rail transportation over an extended or additional railroad line. Finally, it 15 16 17 18 19 20 adds a provision that an entity which is required to 21 file notice with the department of a major 22 modification in rail service, but fails to do so, shall be ineligible for one year for approval to 23 receive financial assistance from the State. 24
