7 COMMITTEE AMENDMENT " \mathcal{H} " to H.P. 1968, L.D. 2665, 8 Bill, "AN ACT to Create the East Pittston Water 9 District."

10 Amend the bill in section 5 in the last paragraph 11 by inserting at the end a new sentence as follows: 12 'The right of eminent domain granted in this section 13 is subject to the Maine Revised Statutes, Title 35-A, 14 chapter 67.'

15 Further amend the bill in section 9 in the 4th 16 line by striking out the following: "5" and inserting 17 in its place the following: '3'

18 Further amend the bill in section 9 in subsection 19 1, in the first paragraph by striking out all of the 20 first to 4th sentences (page 6, lines 19 to 32 in 21 L.D.) and inserting in their place the following: 22 'Within 14 days after the acceptance of this Act, the 23 selectmen of the Town of Pittston, who are especially 24 appointed for this purpose, shall appoint 3 trustees.'

Further amend the bill in section 9 in subsection 1, in the first paragraph in the 4th line from the end (page 6, line 36 in L.D.) by inserting after the following: "elected" the following: 'by the residents of the district'

Further amend the bill in section 9 in subsection 1, in the 2nd paragraph in the 5th line (page 7, line 3 in L.D.) by striking out the following: "2" and inserting in its place the following: 'one' and in the 6th line (page 7, line 4 in L.D.) by striking out the

1 following: "2 for" and inserting in its place the 2 following: 'one for'

3 Further amend the bill in section 9 in subsection 4 2 in the last line (page 7, line 10 in L.D.) by 5 striking out the following: "3" and inserting in its 6 place the following: '2'

7 Further amend the bill in section 16 in the first 8 paragraph in the 9th line (page 10, line 40 in L.D.) 9 by striking out the following: "the first meeting of 10 the town"

11 Further amend the bill in section 16 in the 12 question in the first line (page 11, line 13 in L.D.) 13 by striking out the following: "The Act to 14 Incorporate" and inserting in its place the following: 15 'An Act to Create'

STATEMENT OF FACT

17 This amendment changes the number of trustees of 18 the district from 5 to 3 and provides that the first 19 trustees may be appointed by the selectmen of the Town 20 of Pittston. It makes a cross reference to the Maine 21 Revised Statutes, Title 35-A, governing condemnation 22 proceedings and makes technical corrections in the 23 referendum section.
