## STATEMENT OF FACT

3 The Commission on Governmental Ethics and Election 4 Practices is currently staffed on a part-time basis by 5 an administrative assistant. This individual works 22 6 weeks each year for the commission and works 30 weeks 7 each year in the Office of the Secretary of State 8 supervising the registration of lobbyists.

9 Over the past 12 years, the work the load of commission has increased significantly such that it 10 has become difficult for the staff person to provide 11 12 effective administrative support to the commission 13 while also fulfilling lobbyist registration 14 responsibilities.

15 This bill requests the funds needed to establish 16 the commission's administrative assistant on a 17 full-time basis.
