COMMITTEE AMENDMENT "A" to H.P. 1978, L.D. 2676,
Bill, "AN ACT to Create the South Waterboro Water
District."

Amend the bill by striking out all of the title
and inserting in its place the following:

'AN ACT to Create the Waterboro Water District.'

Further amend the bill in the 2nd paragraph after
the title in the first line (page 1, line 7 in L.D.)
by striking out the following: "South"

Further amend the bill in the 2nd paragraph after
the title in the 2nd line (page 1, line 8 in L.D.) by
striking out the following: "gasoline" and inserting
in its place the following: 'petroleum'

Further amend the bill in the 3rd paragraph after
the title in the last line (page 2, line 4 in L.D.) by
striking out the following: "South"

Further amend the bill in the 4th paragraph after
the title in the 2nd line (page 2, line 6 in L.D.) by
striking out the following: "South"

Further amend the bill by striking out all of
section 1 and inserting in its place the following:

COMMITTEE AMENDMENT "A" to H.P. 1978, L.D. 2676

1 'Sec. 1. Territorial limits; corporate name;
2 purposes. The inhabitants and territory of the Town
3 of Waterboro in York County shall constitute a body
4 politic and corporate under the name of "Waterboro
5 Water District" for the purpose of supplying the
6 inhabitants and others of the district with pure water
7 for domestic, sanitary, commercial, industrial,
8 agricultural and municipal purposes.'

9 Further amend the bill in section 2 in the first
10 and 2nd lines (page 2, lines 33 and 34 in L.D.) by
11 striking out the following: "South"

12 Further amend the bill in section 5 by inserting
13 at the end a new paragraph to read:

14 'The right of eminent domain granted in this
15 section is subject to the Maine Revised Statutes,
16 Title 35-A, chapter 67.'

17 Further amend the bill in section 9, in the 4th
18 line (page 6, line 18 in L.D.) by striking out the
19 following: "5" and inserting in its place the
20 following: '3'

21 Further amend the bill in section 9 by striking
22 out all of subsection 1 and inserting in its place the
23 following:

24 '1. First board. Within 14 days after the
25 acceptance of this Act, the selectmen of the Town of
26 Waterboro, who are especially appointed for this
27 purpose, shall appoint 3 trustees. After the
28 selection of the first board, the only eligibility
29 requirements for the office of trustee of the district
30 shall be residence within the district and eligibility
31 to vote, and all subsequent trustees shall be elected
32 by the residents of the district as provided in the
33 Maine Revised Statutes, Title 35-A, chapter 63 in an
34 annual election to be held on the first Saturday of
35 March in each year.

36 Organization of the board of trustees and its
37 specific powers shall be in accordance with the Maine
38 Revised Statutes, Title 35-A, chapter 63. The first
39 order of business shall be to draw by lot to fix the

1 terms of the trustees. Of the original trustees, one
2 shall serve for one year, one for 2 years and one for
3 3 years. Thereafter, trustees shall be selected to
4 serve for 3-year terms.'

5 Further amend the bill in section 9 in subsection
6 2 in the last line (page 7, line 13 in L.D.) by
7 striking out the following: "3" and inserting in its
8 place the following: '2'

9 Further amend the bill in section 12 in the 2nd
10 paragraph in the 9th line (page 9, line 28 in L.D.) by
11 striking out the following: "South"

12 Further amend the bill in section 16 by striking
13 out all of the 2nd paragraph (page 11, lines 17 to 19
14 in L.D.) and inserting in its place the following:

15 ' "Shall 'AN Act to Create the Waterboro Water
16 District' passed by the Legislature be accepted?"'

17 STATEMENT OF FACT

18 This amendment enlarges the area of the district
19 to cover the entire Town of Waterboro. It also
20 changes the number of trustees of the district from 5
21 to 3 and provides that the first trustees may be
22 appointed by the selectmen of the Town of Waterboro.
23 It makes a cross reference to provisions of the Maine
24 Revised Statutes, Title 35-A, governing condemnation
25 proceedings and makes a technical correction in the
26 form of the referendum question.
