STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-NINE

AN ACT Requiring the State to Conduct a Test to Determine Whether Large Freshwater Salmonids can be Grown in the State's Estuarine Waters.

(EMERGENCY)

 Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted
 as emergencies; and

5 Whereas, there has been a very positive reaction by fishermen in other states to the availability of larger fish in 7 those states; and

9 Whereas, one outcome of this positive reaction has been a considerable increase in the number of out-of-state fishermen; and 11

Whereas, current studies indicate the importance of the 13 fish and game business to Maine's economy; and

15 Whereas, it is a goal of the State to increase tourism; and

17 Whereas, the state agencies involved feel that there is a likelihood that large fish can be produced in state waters; and

Whereas, it is desirable to get an early start on a program
21 that will require a number of years before it produces results; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 12 MRSA c. 606, sub-c. II is enacted to read:

SUBCHAPTER II FRESHWATER SALMONID RESEARCH

37 §6151. Freshwater salmonid research program

 39 The Commissioner of Inland Fisheries and Wildlife and the Commissioner of Marine Resources shall jointly conduct a test
 41 program to determine if above average size rainbow trout and landlocked salmon can be raised in the Kennebec River estuary.

 Rules. There shall be no license required of individuals to fish for the stocked species in the estuary. In accordance with the Maine Administrative Procedure Act, Title 5, chapter 375, the commissioners shall promulgate rules governing the size and number of fish that may be kept and fishing
 methods. The rules shall be consistent with the objective of the test to produce large fish.

2. Native species. The Department of Marine Resources shall monitor the effect of the test stocking on the existing fish population.

3. Timetable. Actual stocking of both species of fish in meaningful quantities shall begin no later than 1991. The Department of Marine Resources shall make a recommendation whether to end this program or to extend it to other estuaries no later than 5 years after the first stocking of fish. The test shall be conducted in a manner that produces data adequate to support the recommendation.

 4. Status reports. The Department of Marine Resources
 15 shall provide the joint standing committee of the Legislature having jurisdiction over marine resources with a status report on
 17 this project by April 1st of each year beginning in 1990.

5. Sunset. This section is repealed on December 31, 1997.

Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Provides \$60,000 in both years of the biennium for the 33 purchase of rainbow trout and landlocked salmon yearlings. 35 Also, this appropriation provides \$15,000 in fiscal 37 year 1989-90 for anticipated 39 contractual services to required conduct data 41 analysis. These funds shall not lapse but shall carry forward to be expended for 43 the purposes cited in this 45 Act.

47 **Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

FISCAL NOTE

This legislation would require a General Fund appropriation to the Department of Marine Resources, Bureau of Marine Development, in the amount of \$75,000 for fiscal year 1989-90 and \$60,000 for fiscal year 1990-91. It is anticipated that this bill would result in a future cost to the General Fund since the program is designed to last approximately 5 years.

STATEMENT OF FACT

15 This bill requires the Department of Inland Fisheries and Wildlife and the Department of Marine Resources to conduct a test 17 to determine if large fish can be grown by stocking yearling landlocked salmon and rainbow trout in the Kennebec River 19 estuary. If this test is successful, the program would be extended to other river estuaries. Because this is a test and 21 because state hatcheries are currently at capacity, fish for this test will be purchased. The test is to be evaluated both on the basis of its ability to produce the desired fish and the effect of the stocking on fish which are native to the estuary.

Since the raising of yearling fish and the analysis of pretest data take several years, this bill carries a fiscal note only for those activities. The remainder of the test years would be funded through increased appropriations to the Department of Marine Resource's annual budget.
