to Purchasers of Manufactured Housing.**

Production of information. Resolved: That the Manufactured Housing Board shall provide information for purchasers of manufactured housing concerning choosing and purchasing manufactured housing, financing manufactured housing, the installation of manufactured housing and consumers' rights concerning the purchase, financing, installation and ownership of manufactured housing. To fulfill this responsibility, the board may reproduce an existing publication which provides the required information; and be it further

Distribution. Resolved: That the board shall provide copies of the information to all manufactured housing dealers licensed in this State. Each dealer shall prominently display a sign which states that the information is available and the dealer will supply a copy to anyone who requests a copy; and be it further

Allocation. Resolved: That the following funds are allocated from Other Special Revenue to carry out the purposes of this resolve.

STATEMENT OF FACT

This resolve is an interim recommendation of the Commission on Manufactured Housing, created by Private and Special Law 1987, chapter 139. This resolve requires the Manufactured Housing Board to produce, and manufactured housing dealers to distribute, a pamphlet providing information to purchasers. It appears that many purchasers and potential purchasers of manufactured housing are not aware of the many facets of shopping and ownership. This pamphlet will help consumers before and after they purchase manufactured housing.
