This amendment makes the following changes to the bill.

- 1. The amendment adds an inadvertently omitted word for grammatical reasons.
- 2. The amendment clarifies references to "local government" by explicitly referring to municipalities and counties.

- 3. The amendment defines the membership of labor organizations and community-based organizations by requiring the Governor to appoint 5 representatives of organized labor and 4 representatives of community-based organizations.
- 21 4. The amendment provides that the bill will apply retroactively to January 23, 1989, the date of the Governor's executive order reconstituting the Human Resource Development Council.

5. Finally, the amendment adds a fiscal note to the bill.
