47	This amendment eliminates egg baskets, laundry carts and poultry boxes from the provisions of the bill. It extends the provisions to cover any misuse of the containers, not merely

- commercial misuse. It adds the provision that possession of these containers shall create the presumption that they are
- possessed in violation of the provisions of the bill. It eliminates the civil penalty established in the bill.
