SENATE AMENDMENT "A " to COMMITTEE AMENDMENT "A" to H.P. 123, L.D. 160, Bill, "An Act to Make Supplemental Allocations from the Highway Fund for the Fiscal Years Ending June 30, 1990 and June 30, 1991"

Amend the amendment in the first paragraph after the title by striking out all of the 3rd to 6th lines (page 1, lines 20 to 23 in amendment) and inserting in its place the following:

'An Act to Make Supplemental Allocations from the Highway Fund for the Fiscal Years Ending June 30, 1989, June 30, 1990, and June 30, 1991, and to Make Other Changes in the Law Necessary for the Proper Operation of State Government'

Further amend the amendment in section 10 under the caption "SECRETARY OF STATE, DEPARTMENT OF THE" by striking out all of the 9th to 16th lines (page 7, lines 21 to 30 in amendment) and inserting in its place the following:

**'Administration - Motor Vehicles**

Personal Services	\$60,000	\$60,000
All Other	267,553	299,713
TOTAL	<u>\$327,553</u>	<u>\$359,713</u>

Provides additional operating expenses as originally budgeted.'

Further amend the amendment in section 10 under the caption "SECRETARY OF STATE, DEPARTMENT OF THE" by striking out all of the last line (page 10, line 24 in amendment) and inserting in its place the following:

9 all of the last line (page 16, line 33 in amendment) and  
inserting in its place the following:

11 'SECTION 11 \$112,759 \$85,027'

13 Further amend the amendment by inserting after section 11  
15 the following:

'Sec. 12. Allocation. The following funds are allocated from  
17 the Highway Fund to carry out the purposes of this Act.


