13	COMMITTEE AMENDMENT "A" to H.P. 274, L.D. 386, Bill, "An Act Concerning the Operation of Motor Vehicles on Private Lands"
15	Amend the bill by striking out everything after the enacting
17	clause and before the statement of fact and inserting in its place the following:
19	·17 MRSA §3853-D is enacted to read:
21	<u>§3853-D. Operating a motor vehicle on land of another</u>

25	<ol> <li>Damage or destruction to farmland. A person who, as a result of operating a motor vehicle on farmland, damages or destroys crops or roads on that farmland, commits a Class E</li> </ol>
27	<u>crime.</u>
29	2. Definitions. As used in this section, unless the context otherwise indicates, the following terms have the following
31	<u>meanings.</u>
33	A. "Farmland" means land used for the production of fruits, vegetables, grains, hay or herbs that consists of 5 or more
35	contiguous acres. The term "farmland" does not include land used for the production of wood products.
37	B. "Motor vehicle" means any self-propelled vehicle not
39	operated exclusively on tracks, including all-terrain vehicles as defined in Title 12, section 7851, but not
41	including snowmobiles.
43	3. Application. This section does not apply to:
45	A. A landowner operating a motor vehicle on farmland owned by that landowner;
47	
49	B. A person given permission by a landowner to operate a motor vehicle on farmland owned by that landowner;

2	C. An agent or employee of a landowner who operates a motor
3	vehicle on farmland owned by that landowner in the scope of that agent's or employee's agency or employment; or
5	
	D. A law enforcement officer who, in an emergency and in
7	the scope of that law enforcement officer's employment,
9	operates a motor vehicle on farmland owned by another.
11	FISCAL NOTE
13	
	This bill could result in additional cases filed throughout
15	the state court system. However, the Judicial Department would absorb the additional costs utilizing existing resources.'

19	STATEMENT OF FACT
21	
	The amendment makes operation of a motor vehicle on farmland
23	that causes damage or destruction to crops or roads on that
	farmland a Class E crime. The law does not apply to a landowner,
25	or a landowner's employee or agent acting within the scope of their employment or agency, a person given permission to operate
27	a motor vehicle by the landowner or a law enforcement officer
	responding to an emergency within the scope of that officer's
29	employment. The amendment also adds a fiscal note.
