Amend the amendment by inserting after the 2nd paragraph  
after the title the following:

'Further amend the bill by striking out everything after the  
title and before the enacting clause

Further amend the bill by inserting at the beginning of the  
first line after the enacting clause the following: 'Sec. 1.' '

Further amend the amendment by inserting before the  
statement of fact the following:

'Further amend the bill by inserting before the emergency  
clause the following:

'Sec. 2. Appropriation. The following funds are appropriated  
from the General Fund to carry out the purposes of this Act.

**FISCAL NOTE**

The cost of producing and mailing the labor law poster may be reduced if additional bills are enacted which would also require changes to this poster.' '

**STATEMENT OF FACT**

This amendment adds an appropriation section and a fiscal note. The amendment also removes the emergency preamble and the emergency clause.
