SENATE AMENDMENT " C " to COMMITTEE AMENDMENT "B" to H.P. 315, L.D. 429, Bill, "An Act Regarding State Forest Practice Laws"

Amend the amendment by striking out all of section 5.

Further amend the amendment in section 9 in that part designated "~~§8612.~~" in the 2nd line (page 4, line 26 in amendment) by striking out the following: "at least 28" and inserting in its place the following: 'by 1991, at least 16'

Further amend the amendment in section 11 in that part designated "~~§8869.~~" in subsection 10 in the 3rd line (page 8, line 40 in amendment) by inserting after the following: "rangers" the following: 'and field foresters'

Further amend the amendment in section 13 in that part designated "~~§8885.~~" in subsection 3 in the first line (page 12, line 9 in amendment) by striking out the following: "this section" and inserting in its place the following: 'subsection 1 shall be due January 1st and July 1st. Reports required under subsection 2'

Further amend the amendment in section 13 in that part designated "~~§8886.~~" in subsection 2 in paragraph A in the 3rd line (page 13, line 3 in amendment) by striking out the following: "section 8884" and inserting in its place the following: 'section 8885'

Further amend the amendment in section 13 in that part designated "~~§8888.~~" in the 3rd line (page 13, line 33 in amendment) by inserting after the following: "rangers" the following: 'and field foresters'


### STATEMENT OF FACT

18 may enforce provisions of this Act, corrects several technical
