An Act Concerning Snowmobile Registrations.



1 **Be it enacted by the People of the State of Maine as follows:**

3 **Sec. 1. 12 MRSA §7824, sub-§1, as enacted by PL 1979, c. 420,**
5 **§1, is amended to read:**

7 **1. Application and issuance.** The commissioner, or an agent
9 designated by him the commissioner, may register and assign a
11 numbered registration number sticker to all snowmobiles upon
13 application and payment of an annual fee by the owner. The
15 sticker shall include the registration number of the snowmobile
17 and the valid registration year. A registration shall be valid
19 for one year commencing July 1st of each year.

21 **Sec. 2. 12 MRSA §7824, sub-§7, as amended by PL 1979, c. 543,**
23 **§77, is repealed.**

25 **Sec. 3. 12 MRSA §7824, sub-§10, ¶B, as enacted by PL 1979, c.**

29 B. The numbered registration number sticker assigned to a
31 snowmobile shall be displayed in such form and manner as the
33 commissioner may determine.

35 **Sec. 4. 12 MRSA §7825, sub-§4, as enacted by PL 1979, c. 420,**
37 **§1, is amended to read:**

39 **4. Temporary registrations and numbers.** The commissioner
may issue temporary numbers and registrations to bona fide
dealers who may, upon the sale or exchange of a snowmobile, issue
them to new owners in order to allow them to operate snowmobiles
for a period of 20 consecutive days only after the day of sale in
lieu of a ~~permanent--number~~ numbered registration sticker as
required by this subchapter.
