IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-NINE

An Act to Assist Local Educational Authorities in Replacing Unsafe School Buses.

1	Be it enacted by the People of the State of Maine as follows:
3	Sec. 1. 29 MRSA §2017, as amended by PL 1979, c. 691, \S 22, is further amended by adding at the end a new paragraph to read:
5	,
7	In addition to the inspection required by the first paragraph of this section, any bus with a model year of 1977 or
9	later shall undergo a yearly safety inspection to determine a safety rating value pursuant to section 2021. The State shall reimburse for the cost of the inspection the appropriate school
11	authorities or the owner.
13	Sec. 2. 29 MRSA §2021 is enacted to read:
15	<u>§2021. School bus safety-rating system</u>
17	 Safety-rating system. The department shall develop a school bus safety-rating system which evaluates seat height, seat
19	<u>back padding, chassis, frame and roof strength and all other</u> elements required in a normal inspection procedure.
21	2. Compiling ratings. Each school shall be responsible for
23	compiling a rating for each bus which that school uses. The school shall forward all rating information to the department.

27	3. Priority list. The department shall maintain a priority list of buses which need to be replaced based on the ratings of the buses.
29	
31	4. Formula. The department shall develop a formula which combines the school funding formula and the bus rating value to equal a percentage of reimbursement due to the municipality which
33	replaces a bus. The formula shall be structured so that the more unsafe a bus, the higher the rating and the greater the
35	percentage of reimbursement.
37	Sec. 3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

these funds shall be used to replace pre-1977 school buses.

STATEMENT OF FACT

This bill provides funding to municipal school districts for the inspection and replacement of unsafe pre-1977 school buses. 9 Two thirds of the money appropriated for school bus purchases 11 will be used to replace pre-1977 buses. The department will develop a safety rating that addresses seat height, seat back padding, chasis, frame and roof strength, as well as the normal 13 inspection procedure. Rating information will be forwarded by 15 the school to the Department of Educational and Cultural Services which will maintain a priority list of unsafe buses based on this 17 A formula will be developed that combines the school data. funding formula plus bus rating to equal the percentage of 19 reimbursement. The more unsafe the bus, the higher the rating and the greater the incentive for schools to replace them.
