13	COMMITTEE AMENDMENT " $\mathcal{H}$ " to H.P. 472, L.D. 637, Bill, "An Act to Improve Personnel Supervision in the Bureau of
15	Intergovernmental Drug Enforcement"
17	Amend the bill in section 3 by striking out all of subsection 4 and inserting in its place the following:
19	'4. Task force investigative agents. The investigative
21	complement of each task force shall be comprised of task force investigative agents who-shall. Agents may be selected from
23	municipal, county and state law enforcement agencies within the State <u>and other state agencies, provided the prospective agent</u>
25	has been certified pursuant to section 2803, subsection 1; or may be other experienced law enforcement officers, provided each has
27	been certified pursuant to section 2803, subsection 1. Agents shall be selected and appointed at the discretion of the director
29	with the concurrence of the commissioner from among those efficers persons nominated by the chief administrative officer of
31	a prospective agent's employing agency <u>and other experienced law</u> <u>enforcement officers who apply</u> . Agents shall serve at the
33	pleasure of the director. Agents shall receive compensation, paid from the budget of the bureau, equivalent to that of a
35	detective in the Maine State Police assignedtotheDrug
37	EnforcementUnit, with respect to both regular and overtime compensation with the additional credit given to seniority based upon law enforcement experience. Allpersonnel If the person
39	selected as agents, - whether - from - a an agent is currently an
41	<u>employee of any</u> municipal er, county or state law enforcement agency, <u>or any other state agency, the person</u> shall be placed on a temporary assignment by the person's employing agency. An

45	employing agency. Notwithstanding any other provisions of law, the person shall retain and continue to accrue seniority and
47	retirement rights and benefits within the person's employing agency for the time in which the person serves as an agent.

COMMITTEE AMENDMENT "H" to H.P. 472, L.D. 637

1 Any person employed as a senior agent or special agent investigator within the Maine State Police may be temporarily 3 assigned to the bureau. During such temporary assignment, the Maine State Police shall retain the positions of senior agent and 5 special agent investigator.' 7 Further amend the bill by inserting at the end before the statement of fact the following: 9 'Sec. 6. 1	STATEMENT OF FACT
3	This amendment allows the Director of the Bureau of
5	Intergovernmental Drug Enforcement to employ experienced law enforcement officers as investigative agents notwithstanding the
7	fact that they are not currently employed by a municipal, county or state agency, provided they have been certified by the Maine
9	Criminal Justice Academy. The amendment also adds fiscal information and an appropriation section.
