An Act Relating to Legislation of an Emergency Nature Introduced in
the 2nd Regular Session or any Special Session.



1 Be it enacted by the People of the State of Maine as follows:

3 3 MRSA §5 is enacted to read:

5 §5. Second regular and special sessions; emergencies

7 Legislation of an emergency nature admitted by the
9 Legislature for consideration during the 2nd regular session and
11 any legislation introduced for consideration in special session
13 must be emergency legislation requiring a vote of 2/3 of all the
15 members of each House and having an effective date earlier than
17 90 days after the adjournment of that session.

STATEMENT OF FACT

19 This bill limits the matters considered as emergencies
21 during the 2nd regular session and all of the legislation
23 considered at any special session to legislation requiring a vote
25 of 2/3 of all the members of each House and an effective date
27 earlier than 90 days after the adjournment of that session.
