27	expeditious manner, the commissioner shall require that all employees of the department involved in any aspect of these				
29	functions shall keep accurate and regular daily time records. These records shall describe the matters worked on, services				
31	performed and amount of time devoted to those matters and services, as well as amounts of money expended in performing				
33	these functions. Records shall be kept for a sufficient duration as determined by the commissioner to establish to his				
35	satisfaction that the fees are appropriate. The following table is repealed on May 1, 1991.
