23	'§1811. License required; definitions
25	No person, partnership, association or corporation, nor any
27	<u>state</u> , county or local governmental units, shall may establish, conduct or maintain in the State any hospital, sanatorium, convalescent home, rest home, nursing home, <u>ambulatory surgical</u>
29	<u>facility</u> or other institution for the hospitalization or nursing care of human beings without first obtaining a license therefor.
31	Hospital, sanatorium, convalescent home, rest home, nursing home, ambulatory surgical facility and other related institution,
33	within the meaning of this chapter, shallmean means any institution, place, building or agency in which any accommodation
35	is maintained, furnished or offered for the hospitalization of the sick or injured or care of any aged or infirm persons
37	requiring or receiving chronic or convalescent care. Nothing in this chapter shall may apply to hotels or other similar places
39	that furnish only board and room, or either, to their guests or to such homes for the aged or blind as may be subject to

1 '§1813. Existing hospitals must obtain licenses 3 No person, partnership, association or corporation, nor any state, county or local governmental units, may continue to 5 operate an existing hospital, sanatorium, convalescent home, rest 7 home er, nursing home or ambulatory surgical facility, nor open a hospital, sanatorium, convalescent home, rest home er, nursing 9 home or ambulatory surgical facility unless such the operation shall-have-been is approved and regularly licensed by the State.'' 11 Further amend the amendment by striking out all of the 7th and 8th paragraphs after the title (page 2, lines 6 to 20 in 13 amendment) and inserting in their place the following: 15 'Further amend the bill in section 4 by striking out all of that part designated "§1815." and inserting in its place the 17 following: 19 '§1815. Fees 21 Each application for a license to operate a hospital, convalescent home or nursing home shall be accompanied by a 23 nonrefundable fee of \$50-for-facilities--less-than-50-beds-in size, -a-fee-of-\$100-for-facilities-51-to-100-beds-in-size, -and-a 25 fee-of-\$200-for-facilities-larger-than-100-beds-in-cize \$10 for 27 each bed contained within the facility. Each application for a license to operate an ambulatory surgical facility shall be accompanied by the fee established by the department. The 29 department shall establish the fee for an ambulatory surgical facility, not to exceed \$250, on the basis of a sliding scale 31 representing size, number of employees and scope of operations. No--such-fee--shall--be--refunded. All licenses issued shall be 33 renewed annually upon payment of a like fee. The state's State's 35 share of all fees received by the department under this chapter shall be deposited in the General Fund. No license granted shall 37 may be assignable or transferable. State hospitals are not required to pay licensing fees.' ' 39 STATEMENT OF FACT 41 43 This amendment incorporates all of the changes made in House Amendment "A" to Committee Amendment "A" except that it clarifies the licensing fee applicable to ambulatory surgical facilities. 45
