29	5. Selling wild birds. A person is guilty of selling wild birds if that person sells or possesses for sale any wild bird.

33	plumage of lawfully taken wild birds if that sale does not violate regulations of the United States Federal Migratory Bird Treaty Act.

27 .	This amendment makes it clear that the sale of plumage from lawfully taken birds is not illegal. It retains the current
29	penalties for illegally selling fish, raising the additional fine for illegal possession of fish from \$5 per fish to \$20 per fish.
31	The amendment also replaces the word "game" with "wild birds and wild animals".
