COMMITTEE AMENDMENT "A" to H.P. 950, L.D. 1318, "Resolve, to Establish a Commission to Study Town Supervision of Private Roads"

Amend the resolve in the emergency preamble in the 5th paragraph in the last line (page 1, line 16 in L.D.) by striking out the word "July" and inserting in its place the word 'September'

Further amend the resolve in that part designated "Appointment." in the 2nd line (page 2, line 14 in L.D.) by striking out the following: "7" and inserting in its place the following: '8'

Further amend the resolve in that part designated "Appointment." by striking out all of subsection 1 (page 2, lines 16 to 22 in L.D.) and inserting in its place the following:

'1. Two Senators appointed by the President of the Senate, including one from the Joint Standing Committee on Transportation and one from the Joint Standing Committee on State and Local Government; and 3 Representatives appointed by the Speaker of the House of Representatives, including 2 from the Joint Standing Committee on Transportation and one from the Joint Standing Committee on State and Local Government. The commission shall select a chair from the legislative members.'

Further amend the resolve by striking out all of that part designated "Report." (page 2, lines 51 and 52 and page 3, lines 1 to 7 in L.D.) and inserting in its place the following:

'Report. Resolved: That the commission shall submit its report, together with any necessary implementing legislation, to the Second Regular Session of the 114th Legislature by December 1, 1989; and be it further'

Further amend the resolve by striking out all of that part designated "Appropriation." (page 3, lines 28 to 51 and page 4, lines 1 and 2 in L.D.) and inserting in its place the following:

Further amend the resolve by inserting after the emergency
clause and before the statement of fact the following:

'FISCAL NOTE

Enactment of this bill requires a General Fund appropriation
of \$3,200 in fiscal year 1989-90 to fund the per diem, meeting
and related expenses of the Commission to Study Town Supervision
of Private Roads.'

STATEMENT OF FACT

The amendment modifies the study to report to the
Legislature rather than a joint standing committee. It also
changes the membership to one Senator and 2 Representatives from
the Joint Standing Committee on Transportation and one Senator
and one Representative from the Joint Standing Committee on State
and Local Government.
